Company sues F.P. over solicitation ban

Claims village restriction 'unconstitutional,' hurts biz

A pet control company is suing Floral Park over what the company claims is an unconstitutional village ban on door-to-door solicitations that the company says hurts business, according to court records.

The South-based company, Agria Environmental, said the ban is "disparate treatment of the First and Fourteenth Amendments," according to court records.

The case is scheduled to be heard by

the village "in a matter of days," says Agria Environmental attorney, James H. ...

John Ryan, the Floral Park village attorney, declined to comment.

Court documents show that village officials agreed to a temporary settlement with Agria on Aug. 23 that allows the company to solicit for the time being.

The temporary agreement allows Agria representatives to solicit in the village between 9 a.m. and dusk.

Floral Park's code, passed

in 1963 and amended in 1994, bans all commercial solicitations in the village. It does not allow any exceptions or accommodations for "bank, food, public or utility sales" for people or other organizations.

Agria says the ban hurts its business, which is done almost exclusively through door-to-door solicitations, according to court documents.

A nearly half of Agria's sales occur between 9 p.m. and dusk, according to court records.

members of the Board of Education, including James Hadden, who serves the New Hyde Park-Garden City Park community, objected to the Nassau County Board of Education's decision to place polling at the high school following a five-year long controversy about its location.
